- With no previous notice, the itinerary and program of the tours can be modified due to bad weather conditions or any other conditions beyond Ambiental direct control that can risk the safety of the tour.
- The tours described are operated according to the specific conditions established by the EMBRATUR normative deliberation NR. 161 (09/aug/1985), available for the passengers at request.
- Cancellations: Land Arrangements: If you cancel your booked tour, you must inform Ambiental Expedições in writing. Cancellation charges are calculated on the day that the written notification is received by Ambiental Expedições. The table below shows the cancellations fees according to the date we receive your request.
